The **Make a Move with Jagger Foundation** helps by providing direct assistance to families who find themselves managing unexpected challenges by covering the cost of specialized equipment and supplies. Children living with different abilities deserve to have the same opportunities as other children and the ability to realize their full potential. From transportation, wheelchair modifications, adapted car seats, adapted bicycles, adapted strollers, home modifications to assistive communication devices, The Make a Move with Jagger Foundation helps families purchase a wide range of equipment not funded by any other source.

Qualifications for applying to the Make a Move with Jagger Foundation Financial Assistance Program:

Complete the Application Form attached for the **Make a Move with Jagger Foundation Financial Assistance Program.**

Write a letter telling us about your child, the family situation, what the need is and how our funds will help. Share what difficulties you have encountered obtaining this piece of equipment for your child.
A copy of a medical doctor's diagnosis for your child.

A letter from a third party (i.e. a social agency, therapist or doctor that helps with your child) supporting the request.

Two estimates from the vendor(s)/service provider(s) on the cost of the items for which financial assistance is being requested.

Please include any other confirmed sources of funding.



Make a Move with Jagger Foundation

Financial Assistance Program Granting Policies:

Application is on behalf of a child or youth under the age of 18 who resides in Central Alberta, and must be a citizen or have permanent residency of Canada.

Item or equipment being requested must improve applicant's quality of life by supporting their health, championing their ability, or nurturing their development.

If any information is missing or the Financial Assistance Program application form is incomplete, it may be returned for completion, resulting in a delay in processing the request.

The level of funding assistance may vary based on the cost of the item and the availability of funds at the time the request is received.

Payment is made to the vendor.

Applicants agree that the decisions of the Make a Move with Jagger Foundation are final and that the Make a Move with Jagger Foundation accepts no liability in such regard.

Granting policies may be changed by the Make a Move with Jagger Foundation at any time without notice.

Make a Move with Jagger Foundation Financial Assistance Program Selection Process:

The Selection Committee will review all qualified applications and determine which requests can be funded based on suitability of applications as well as available funds during the selection period.

Successful applicants will be notified by the Make a Move with Jagger Foundation. Appeals will not be considered, as the Committee selections are final.
